The EU's response to the COVID-19 pandemic and the position of the PES Group

The Franco-German initiative for the post-COVID19 recovery

On Monday 18 May, German Chancellor Angela Merkel and French President Emmanuel Macron presented their joint initiative for a €500 billion recovery fund to help European Union countries face the consequences of the COVID-19 pandemic. This fund would come in addition to the €500 billion of the emergency measures adopted in April and to the approximately €1000 billion EU budget.

The key points of the French-German proposal are as follows:

- The fund would be fully financed by debt issued by the European Union, marking a change in Germany's position against common European bonds;
- The fund would be integrated into the European Union's Multiannual Financial Framework;
- The funds would be disbursed by the European Commission in the form of grants based on regional and sectoral criteria.



The proposal was welcomed by the European Commission, which is due to present its proposal for the recovery and the Multiannual Financial Framework on 27 May, but it would still require the approval by unanimity of the European Council, and it did already meet the reactions of some Member States during the Eurogroup held on the following day (details below).

The Franco-German proposal was welcomed by several governments, including Italy and Spain. Iratxe García Pérez, S&D Group President, said on <u>Twitter</u> that the proposal is an important starting point for discussion in the European Council as it would be based on grants and would fall into the remits of the MFF and thereby, the European Parliament's scrutiny. However, the European Parliament still expects from the European Commission a bigger EU budget, based on new own resources, and having a stronger social focus.

The Council of the European Union

Eurogroup

During the Eurogroup, Austria, Denmark and the Netherlands were against the Franco-German proposal for a €500 billion recovery fund that would offer grants to EU countries hit by the pandemic and said they will present an alternative.

The Council also adopted SURE, a temporary scheme to mitigate unemployment risks, which can provide up to €100 billion of loans under favourable terms to Member States.

European Commission

Biodiversity

European Commission President Ursula von der Leyen had announced that the EU Biodiversity Strategy would be one of the pillars of the European Green Deal. Today, European Commission Executive Vice-President Frans Timmermans, in charge of the European Green Deal, unveiled the proposal, which includes a number of key elements:

- The Biodiversity strategy is a central element of the EU's recovery plan, crucial to
 preventing and building resilience to future outbreaks and providing immediate
 business and investment opportunities for restoring the EU's economy;
- It aims at putting back biodiversity on the path to recovery by 2030, including transforming at least 30% of Europe's lands and seas into effectively managed protected areas and bringing back at least 10% of agricultural area under high-diversity landscape features;
- It also aims to make biodiversity considerations an integral part of the EU's overall economic growth strategy;
- Funding of € 20 billion per year will be unlocked for biodiversity through various sources, including EU funds, national and private funding.

The European Committee of the Regions is addressing parts of the topic through an opinion on "Stepping up EU action to protect and restore the world's forests", drafted by PES Group member and ENVE Commission coordinator Roby Biwer, Member of Bettembourg Municipal Council (Luxembourg). The opinion is due for adoption at the 1-2 July plenary session.

Following the proposal, Biwer commented: "The biodiversity strategy is a step in the right direction. The potential of cities and regions to halt biodiversity loss and restore nature



must be fully used. Local and regional governments should play a leading role. We need to be more ambitious in our efforts to put Europe on the path to sustainable recovery."

Farm to Fork

Also promised within the first 100 days of the new European Commission, the "Farm to Fork" strategy promises to be a revolution. In presenting the proposal, Frans Timmermans stressed the strategy's strong link with the European Green Deal:

- The Farm to Fork Strategy is also considered a central element of the EU's recovery plan;
- It will reduce the environmental and climate footprint of the EU food system and strengthen its resilience, protecting citizens' health and ensuring the livelihoods of economic operators;
- The Strategy sets concrete targets to transform the EU's food system, including a
 reduction by 50% of the use and risk of pesticides, a reduction by at least 20% of
 the use of fertilizers, a reduction by 50% in sales of antimicrobials used for farmed
 animals and aquaculture, and reaching 25% of agricultural land under organic
 farming;
- It also proposes ambitious measures to ensure that the healthy option is the easiest for EU citizens, including improved labelling.

The European Committee of the Regions rapporteur Guido Milana, Member of Olevano Romano Municipal Council (Italy) and PES Group member, commented: "Tackling the environmental and climate footprint of our food system has become more urgent than ever. Cities and regions will be key in delivering the Farm to Fork Strategy in order to support our farmers and protect our consumers."



Initiatives for cities and regions

Transformative Action Award, 2020

The European Sustainability Award, co-organised by ICLEI (Local Governments for Sustainability), the Basque Country, and the City of Aalborg (Denmark) and supported by the European Committee of the Regions and the European Investment Bank, is awarded to a city, region or civil society organisation, which implements the 15 pathways outlined in the Basque Declaration to bring about the socio-cultural, socio-economic, and technological transformation of their community.

The award consists, among other things, of €10,000 to kick-start a Transformative Action in your city, region or municipality. Applicants should complete and submit their application form by 23:59 (CEST), 31 July 2020.

European Committee of the Regions

The first ever online European Committee of the Regions' Bureau meeting was held on 19 May. It adopted, in particular, procedures for remote votings in commission meetings and



in plenary and outlined the agenda of the Committee's next plenary session of 30 June - 2 July. The July plenary session will in particular focus on the Committee's reaction to the Commission proposal for a new Multiannual Final Framework (MFF). All together, the agenda foresees the adoption of three resolutions (on the Committee's political priorities 2020-2025, on the MFF and on the Commission Work programme for 2021) and of 8 opinions, among which the following opinions drafted by PES members: Just Transition Fund (Vojko Obersnel), Stepping up EU Action to Protect and Restore the World's Forests (Roby Biwer), Towards a Roadmap for Clean Hydrogen – the contribution of local and regional authorities to a climate-neutral Europe (Birgit Honé). Health Commissioner Stella Kyriakidis and Thierry Breton, Commissioner for the Internal market, are expected to address the plenary session.

Young local leaders have a last chance to apply for the Young Elected Politicians programme! The final deadline is now set for 31 May:
