## The EU's response to the COVID-19 pandemic and the position of the PES Group

---

### European Commission

#### *MFF and Recovery Plan*

Following up its proposal of a recovery plan and new Multiannual Financial Framework of last week, on Wednesday 3 June, the European Commission proposed modifications to its budget for 2020 to make funds available for the regions most in need and businesses already in 2020. Additional EUR 11.5 billion should become available for REACT-EU, the Solvency Support Instrument and the European Fund for Sustainable Development (EFSD) as early as possible this year.

The next European Council is due to take place on 19 June. In the meanwhile, European Council President Charles Michel is speaking to leaders to try to find a compromise on the Multiannual Financial Framework and the Recovery Plan, but the fact that leaders will not meet in person casts a shadow over the prospects of the European Council meeting.

## *Social rights*

The European Commission launched the second-stage consultation on a possible initiative concerning fair minimum wages on Wednesday 3 June. This initiative was scheduled already before the coronavirus pandemic but obviously becomes even more topical in the current context of social crisis.

After a first consultation of social partners on the possibility of an EU action concerning minimum wages launched in February 2020, the second-stage consultation document sets out the fundamental policy objectives that an EU action in this field will have, namely:

- Set minimum wage levels to ensure that no worker earns a living below the 60% of the median national wage;
- Ensure all workers are covered by minimum wages, whether or not they are set through collective bargaining or statutory measures;
- Establish clear and stable criteria for minimum wage updates at the national level.

## *Brexit*

On Tuesday 2 June, the fourth round of negotiations between the European Union and the United Kingdom started. Ahead of the meeting, the S&D Group called for significant progress. At this stage, it is still unclear to what extent Brexit will be affected by the COVID-19 pandemic.

On 29 May, the UK and Poland signed a treaty to guarantee the right of British and Polish citizens to stand and vote in local elections in each other's countries following the UK's exit from the EU. This is the fourth treaty of this kind signed, following the ones with Spain, Portugal and Luxembourg last year.

## European Parliament

### *Civil Liberties, Justice and Home Affairs*

On Thursday 4 June, Members of the Civil Liberties, Justice and Home Affairs Committee (LIBE) adopted a motion for a resolution by S&D Group rapporteur Juan Fernando López Aguilar (Spain) on the situation in the Schengen area following the COVID-19 outbreak. The resolution focuses on the importance of remaining vigilant about the temporary suspension of Schengen by Member States, recalling that it is an important achievement for the European Union. It also stresses that more targeted restrictions applicable at regional level, including cross-border regions, would have been more appropriate and less intrusive. Last but not least, the rapporteur considers necessary a reflection on how to enhance mutual trust between Member States and ensure a truly European governance of the Schengen area.

## The European progressive family

On Tuesday 2 June, the President of the European Commission Ursula von der Leyen joined the S&D Group for a debate on the Recovery Plan. Von der Leyen praised the action of the European Commission during the crisis (derogation states aids, derogation Stability and Growth Pact, CRII, SURE...) in order to inject very quickly liquidities in the internal market. Beyond this urgent response, she insisted that the *Next Generation EU* package is incorporated into the MFF, which will allow the European Parliament to exert its control.

## The fight against fake news

---

The European Union is preparing new sanctions on a group of Russian hackers to address foreign hacking that has been really intense during the COVID-19 crisis. The sanctions, expected later this year, would be the first application of the EU's so-called cyber sanctions regime, since it was adopted in May 2019, and is a result of Germany's effort to bring a European response to the cyber-attack on the Bundestag in 2015. But how would it work?

The meeting of the Commission for the Environment, Climate change and Energy (ENVE) on Monday 8 June will be the first meeting since March with votes on the agenda. Out of the 5 opinions to be adopted, there are two highlights: the draft opinion by PES Group member and Minister for Federal and European Affairs and Regional Development of Lower Saxony, Birgit Honé, on clean hydrogen, as well as the draft opinion by the EPP member and Mayor of Warsaw, Rafał Trzaskowski on the Climate Pact. Trzaskowski is also running in the Polish presidential elections of 28 June and has good chances to challenge the incumbent conservative President Duda (ECR) in the second round.
