4 May	1 165 095 cases 136 367 deaths	The European Commission published the latest package of exceptional measures to further support the agricultural and food sectors most affected by the coronavirus crisis.
		The European Commission registered €7.4 billion in pledges from donors worldwide during the <u>Coronavirus Global Response pledging event</u> , gathering funding to ensure the collaborative development and universal deployment of diagnostics, treatments and vaccines against coronavirus.
		The <u>European Parliament Budget Committee</u> voted on a request for a contingency plan to extend all EU programmes beyond 2020.
5 May	1 174 394 cases 137 761 deaths	EU ministers responsible for employment and social affairs discussed the national measures taken or foreseen to mitigate the negative consequences of the crisis on the labour markets and the economy.

		EU ministers responsible for telecommunications discussed the use of tracing apps in tackling the COVID-19 pandemic as well as the role of the digital sector in the post-COVID-19 recovery.
6 May	1 186 111 cases 139 750 deaths	The European Commission released the <u>spring</u> <u>economic forecast</u> , predicting that the EU economy will face an unprecedented annual decline of 7.4%. The <u>EU-Western Balkans Zagreb Summit</u> took place via video conference to discuss a new phase of close
		cooperation with the EU's partners.
7 May	1 203 381 cases 141 999 deaths	The European Commission <u>approved all requests</u> <u>made by 18 Member States</u> for support with the preparation of their territorial just transition plans, which each Member State will have to draw up to get access to funding from the Just Transition Mechanism.
		The European Commission put forward a comprehensive <u>Action Plan</u> to further strengthen the EU's fight against money laundering and terrorist financing.
		The European Commission issued a <u>communication</u> <u>providing guidance</u> on free movement of health professionals and minimum harmonisation of training in relation to COVID-19 emergency measures.

The EU's response to the COVID-19 pandemic and the position of the PES Group

The European Committee of the Regions



The Committee adopted on 8 May a Declaration on "local and regional authorities as actors of the European response to the COVID-19 crisis". At the initiative of the PES Group, the declaration included the following key points:

- The stress on the social dimension of the COVID-19 crisis,
- The need to introduce an ambitious EU **recovery fund** within the next Multiannual Financial Framework,
- The consideration of Green Deal objectives in the recovery plan,
- The gender dimension of the COVID-19 crisis,
- The **democratic dimension** and the opportunity that the crisis represents for a reform **of the EU's governance**.

The outcome of the vote was:

- 173 Votes 52% participation
- Yes: 133 76%
- No: 16 9.2%
- Abstention: 24 13.8%

### New initiatives of the European Commission

The European Commission did not present the new Multiannual Financial Framework (MFF) proposal this week, as initially foreseen. The MFF may be presented on 13 May but the option of a further postponement by one week still remains open. The European Parliament puts all its focus on making the recovery closely linked to the MFF in order to have some parliamentary scrutiny for this big part of the future budget. If the European Parliament considers the new Commission proposal worth discussing, it is willing to quickly enter interinstitutional negotiations to reach an agreement, the June Council date still being plausible. If not, the European Parliament will plead for an extension of the 2014-2020 programmes with a top-up of some specific programmes to finance the economic recovery. However, the extension of programmes might prove problematic since it is not clear under which conditions they will be prolonged.

It is also important to note that the Commission published a new package of measures to further support the agricultural and food sectors affected by the coronavirus crisis. These include private storage aid for the dairy and meat sectors, the temporary authorisation to self-organise market measures by operators in hard hit sectors, and flexibility in the implementation of market support programmes. On top of these market measures, the Commission proposed to allow Member States to use rural development funds to compensate farmers and small agri-food businesses with amounts of up to  $\in$ 5 000 and  $\notin$ 50 000 respectively.

## The European Parliament

### Budget

On Monday 4 May, the Budget Committee of the European Parliament adopted a report (co-rapporteurs Jan Olbrycht/EPP and Margarida Marques/S&D), asking the European Commission to set up a contingency plan, due to the possible delay of the agreement on the next MFF, which might not enter into force on 1 January 2021. The Budget Committee requests that the Commission provides a safety net to protect the beneficiaries of the programmes by ensuring continuity of funding. Furthermore, it proposes targeted reinforcements and revisions of rules to address the immediate economic and social consequences of the COVID-19 crisis and support the recovery.

## The Council of the European Union

On Tuesday 5 May, the EU employment and social affairs ministers presented different national measures they had already taken, as well as those they plan to introduce, such as temporary short-time work schemes and lay-offs measures, deferred or reduced tax payments of SMEs, and so on.

"It was agreed that additional efforts and even a stronger response will be needed to achieve full recovery", said Josip Aladrovic, Minister of Labour and Pension System of Croatia. Nicholas Schmit (PES/Luxembourg), European Commissioner for Jobs and Social Rights, stressed that it is important to urgently find an agreement on the new SURE instrument by 1 June. "The recovery [...] must be geared towards a more resilient, fair and sustainable Union, one that has people at its heart. EU health and safety standards must be fully respected. In these endeavours, the European Pillar of Social Rights remains our compass," he added.

The European Commission has also brought forward its work on an Updated Youth Guarantee and an Child Guarantee as well as common standards on minimum income to guarantee that young people will be protected in the aftermath of the crisis.
