1. Short Description

2. Who is responsible for the processing of personal data?

The European Committee of the Regions (CoR) is responsible (as controller) for the processing of personal data. The responsible service is the CoR PES Group Secretariat, (pes-group@cor.europa.eu)

3. What is the purpose of the processing?

To record PES Group newsletter subscribers personal data in order send them the newsletter

4. What is the legal basis for the processing?

Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body,

processing is necessary for compliance with a legal obligation to which the controller is subject, or
